#### Introduction to HHAP

- Assembly Bill (AB) 101 established the Homeless Housing, Assistance, and Prevention Program (HHAP) to provide one-time flexible block grant funds to jurisdictions to support regional coordination and to expand or develop local capacity to address their immediate homelessness challenges
- ► The state's Homeless Coordinating and Financing Council (HCFC) administers the grant funding to local jurisdictions to continue efforts to end and prevent homelessness in their communities.
- Statewide allocations:
  - HHAP 1: \$650 million
  - HHAP 2: \$300 million
  - HHAP 3, 4 & 5: \$1 billion per funding round
- ► Round 5 Application Deadline: March 27, 2024

- → HSH implemented multi-year spending plans to ensure that the HHAP grant investments can sustain prior year programmatic investments made with onetime funding
- → HHAP Funding has strict obligation deadlines that require 75-100% of funding to be obligated within the first 2 years of the grant period
- HHAP award allocation methodology has shifted over the years which has impacted the total funding for HSH



### **Program Investments with HHAP Funding**

- → HHAP Round 1: Funded operations at five shelters including the construction of the Bayview SAFE Navigation Center that can serve up to 203 guests, and funded development of "Home by the Bay" strategic plan and other community planning projects
- → HHAP Round 2: Funding focused on sustaining Shelter In Place (SIP) hotel operations and service costs that were not FEMA eligible, as well start-up operations at the Transitional Age Youth (TAY) permanent supportive housing site, Artmar Hotel
- HHAP Round 3: Funding focused on sustaining operating costs for 711 Post and Baldwin SAFE Navigation Center (430 beds) and supporting proposed 24/7 TAY drop-in center at 888 Post TAY Navigation Center
- HHAP Round 4: Funding focused on sustaining expanded shelter and navigation center investments and maintaining capacity building work, including support for the HSH's Homeless Management Information System called the Online Navigation and Entry (ONE) System

#### **HHAP 5 - Purpose of Funds**

- ► To organize and deploy a full array of homelessness programs and resources comprehensively and effectively statewide.
- ► Sustain existing federal, state, and local investments towardslong-term sustainability of housing and supportive services.
- Prioritize permanent housing solutions.
- ► Require a youth set aside to spend 10 percent of the total allocation on youth
- ← Caps administrative costs at 7 percent of each allocation plus 1 percent allowable for expenses associated with the City's Homeless Management Information System (HMIS).
  - HMIS is the local information technology system that collects client-level data on housing and homeless services. HSH uses a customized Clarity Human Services data system known locally as the Online Navigation and Entry (ONE) system.
