Deputy City Attorney Radtke also (through Commissioner Evans) stated that since this is an advisory body and does not have a binding requirement per the law, he is comfortable with amending the Nomination Committee's quorum requirement section of the bylaws.

Also, a conflict-of-interest training was suggested for each advisory body member to assist with understanding their conflict-of-interest responsibility.
