Members of the public attending the meeting in person will have an opportunity to provide public comment on every action or discussion item.

In addition to in-person public comment, the Commission will hear up to 10 minutes of remote public comment on each action/discussion items, and during general public comment. The Commission will hear remote public comment on items in the order that commenters add themselves to the queue to comment on the item. Because of the 10-minute time limit, it is possible that not every person in the queue will have an opportunity to provide remote public comment. Remote public comment from people who have received an accommodation due to disability (as described below) will not count toward the 10-minute limit.

### **Providing Public Comment Remotely**

#### **Listen or Provide Public Comment Via Phone**

1. Dial **415-655-0001** and enter access code **2662 392 0896** then #
2. Press # again to join the meeting.
3. You will hear a beep when you join the meeting. Please note, if you are calling in before the official meeting start time, the phone line will remain silent.
4. Wait for Public Comment to be announced.
5. When the Chair or Commission Secretary calls for Public Comment, dial '\*' then '3' to be added to the speaker line.
6. You will then hear "You have raised your hand to ask a question. Please wait to speak until the host calls on you."
7. Ensure you are in a quiet location. Before you speak, mute the sound of any equipment around you, including televisions, radios, and computers. It is especially important that you mute your computer (if you are watching via the web link) so there is no echo sound when you speak.
8. To withdraw your request to speak, press '\*' then '3'. – you will hear: "You have lowered your hand."
9. When the Chair or Commission Secretary states "Welcome Caller," you are encouraged to state your name clearly. As soon as you speak, you will have up to three minutes to provide your comments.
10. Once your time has expired, you will be moved out of the speaker line and back as a participant in the meeting (unless you disconnect). You will hear "Your line has been muted." Please press '\*' then '3' to lower your hand.
11. Participants who wish to speak on other public comment periods can stay on the meeting line and listen for the next public comment opportunity.

APPROVAL IS REQUIRED.**

- 1) The Department of Homelessness and Supportive Housing (HSH) Contracts team requests authorization to amend the existing grant with Episcopal Community Services (ECS) for the provision of support services at the Hotel Diva for the period of August 1, 2021 to June 30, 2027, in an additional amount of \$2,986,396. The addition of funds includes a Cost of Doing Business (CODB) increase for fiscal years (FY) 24-25 to FY 26-27, and three additional performance years. The new amount is \$5,208,598, which includes a 20 percent contingency of \$597,279 on the FY 24-25 through FY 26-27 amounts.
- 2) Requesting authorization to amend the existing grant with Episcopal Community Services (ECS) for the provision of support services at the Tahanan Apartments for the period of August 1, 2021, to June 30, 2027, in an additional amount of **\$3,264,913**. The new amount is **\$5,774,635**, which includes a 20 percent contingency of **\$652,983** on the FY 24-25 through FY 26-27 amounts.
- 3) Requesting authorization to amend the existing grant agreement with Larkin Street Youth Services Castro Youth Housing Initiative - Transitional Living Program for the period of July 1, 2021 – June 30, 2026, in an additional amount of \$3,136,668, plus a 15% contingency for a revised amount of \$8,319,647.
- 4) Requesting authorization to amend the existing grant agreement with Larkin Street Youth Services Transitional Housing at Geary House (G-House) for the period of July 1, 2019 – June 30, 2028, in an additional amount of \$3,824,720, plus a 20% contingency for a revised amount of \$8,574,662.
