VISION

We believe that housing is a human right. We envision a San Francisco where everyone has a safe, stable home that meets them where they are and gives them what they need. We believe that all people deserve housing, shelter, and safe spaces, and that San Francisco's work is not finished until this goal is achieved. We envision a system that sees and centers the whole person/family and that recognizes and combats historical oppression. We are committed to ensuring that everyone has the housing, supports, community, and opportunities they need to thrive.

We envision a Coordinated Entry system that is helpful, healing, and equitable for both people experiencing homelessness and those providing services. We strive to create a community-centered system that connects people to the homelessness response system, understands people, and identifies and matches resources to meet their needs.

We recognize that Coordinated Entry (CE) is a process and entry point to the homelessness response system, but it is not the end point. While we will intentionally use the resources we have to serve those experiencing homelessness, we know that we need more than San Francisco currently has to offer. The CE system is an integral part to reaching our vision, and we will continue to use our resources in ways that help us move closer towards this goal.

We empower people who have and are experiencing homelessness to participate in this process at all levels and make decisions regarding the Coordinated Entry System.
